





## Winning Alliance: PCTV, TVTEL and Aldea Solutions unite for the live production of the UEFA Champions League for TNT Sports Mexico

With the transmission of the Super Cup match between Chelsea F.C. and Villarreal C.F. on August 11, TNT Sports Mexico debuted its streaming for HBO Max and for TNT on cable television, for the exclusive distribution of the UEFA Champions League with 138 live matches. To make this possible, Warner Media selected the consortium comprised of PCTV and the Marcatel Group companies - TVTEL and Aldea Solutions - who will produce all Champions League content from Mexico City that will be broadcasted on HBO, TNT and Cinemax.

Aldea will facilitate the connectivity, via its fiber optic network, carrying the match signals from Europe and distribute to its studios in Mexico, Brazil, Chile and Argentina, as well as provide the transport of produced signals between them".

With this agreement with Warner Media, TVTEL enters the Mexican market by providing remote production services, while its alliance with PCTV will enable it to offer a first-level production center, thus further increasing its service offering in the region.
